Mike Martin reported the following:

The Governor's Proposed Budget has been released, Mike pointed out several items of interest included in the proposal:

- COLA for LCFF in the amount of 3.46%
- Allocation of \$3 Billion to assist employers with CALSTRS Employer Rates
- \$576 Million for Special Education (not SELPA's) focusing on outside of the SELPA's so it doesn't go the MOE allocations
- \$10 Million Longitudinal Educational Data System
- \$350,000 to "merge the Dashboard, the LCAP electronic template, and other school site and school district reporting tools (including the School Accountability Report Card) into a single web-based application"
- Additional \$125 million to increase preschool slots
- \$750 Million for Universal Full-day kindergarten

Mike and Leslie both pointed out that there will be many "Trailer Bills" and things will change prior to the Governor signing the final budget. Additional information will be provided at future meetings of the board.
