Staff and students who do not currently have access to a device at home will be provided the appropriate technology. Small School District Association and the California Department of Education have collaborated with MCOE to provide 178 chrome books to our local districts for student use.

Modoc County Office of Education does not have any schools to close during the COVID-19 emergency. Accessibility for special education, English learners, foster youth and low-income students will be addressed as needed:

~Students who are English learners with an IEP will continue to receive designated and integrated instruction and scaffolding from teachers during Distance Learning.

~Students with IEPs will continue to receive case manager support and services.

~Case managers will coordinate IEP Amendment meetings for all students/families to discuss and determine individualized IEP services and supports in a Distance Learning model.

~Students and families who are foster youth and homeless or at risk of homelessness will receive pro-active outreach regarding needed educational and community support by foster/homeless case managers.
